If the application for registration is not lodged before the date of expiry of the reservation period, an application may be lodged to extend the reservation period for a further two months.

Any application to extend the reservation of a name must be received prior to the expiry of the reservation period and be accompanied by the prescribed fee. The application must specify the reasons for the extension and why the name cannot be registered within the current reservation period. An extension will only be granted if valid reasons exist.
