**NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 (Cth).**

On 20 June 2014 Australian Pacific Coal Limited (**AQC**) completed the allotment of 18,750,000 fully paid AQC ordinary shares (**New Shares ASOF**) raising \$75,000 in accordance with the terms of its agreement with The Australian Special Opportunity Fund LP, which was announced to the market on 1 October 2012.

Australian Pacific Coal Limited (**AQC**) confirms that on 20 June 2014 it has also issued 5,331,632 fully paid ordinary shares in the capital of AQC (**New Shares**) at 0.49 cents per share.
