NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 (Cth).

On 27 August 2013 Australian Pacific Coal Limited (**AQC**) completed the allotment of 14,285,714 fully paid AQC ordinary shares (**New Shares**) raising \$100,000 in accordance with the terms of its agreement with The Australian Special Opportunity Fund LP, which was announced to the market on 1 October 2012.
