

During the quarter the company strived to exploit existing opportunities arising in connection with its Mantuan Downs bentonite deposit and the recently acquired Filtek wastewater solutions business. Despite much enthusiasm and hard work it has become clear to the board that neither of these endeavours is likely to generate significant revenues in the near future.
