NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001 (CTH).

On 22 May 2014 Australian Pacific Coal Limited (**AQC**) completed the allotment of 18,750,000 fully paid AQC ordinary shares (**New Shares**) raising \$75,000 in accordance with the terms of its agreement with The Australian Special Opportunity Fund LP, which was announced to the market on 1 October 2012.
